14.1. Informal consultation with the owner of The Cross Hands, Alveston.

Cllrs Brian Lee and Phil Squires met with the owner of the Cross Hands to discuss his possible application to open a "Fish and Chip Takeaway" in rooms below the pub and accessed through their large car park. The idea is in its early stages but BL and PS were impressed with the care that the owner was showing to ensure the facility would operate with minimal impact to the locality. The proposal would

include the installation of a very efficient filtering system in the kitchen vents, serviced litter bins in and adjacent to the car park and assurances that good behaviour in the locality would be actively encouraged.

Although not offering any formal agreement until full plans are placed before the Council, Cllrs Brian Lee and Phil Squires commented to the owner that his plans seemed to be acceptable and wished him well with his endeavour.
