Cllr Reeve briefed Cllrs on the SGC sites committee meeting in which she attended and presented a five-minute objection to the application based on due consideration for parking in the surrounding area. (MR) stated that the application was approved however, Bromford agreed to work with the Council/s to look at the land in Quarry Rd to see what could be done relating to parking issues.

15. Matters the Chair Considers Urgent

(AC) requested feed back relating to what the Planning Committee wish to submit toward the "White Paper" consultation. (PC) advised that the Parish Council should give representation especially relating to the "snatching" of the Green Belt. (LF) confirmed (PC) question relating to time constraints relating to Planning approval and construction. In the area (LF) confirmed that there have been substantially more applications approved than housing built, and the developers are holding on this to ensure optimum sale price can be obtained. The Parish Council is a purely advisory participant in the planning process and the proposal on the white paper is to extend this to district councils. The only future participation for Town and Parish Councils will be on the reserve matters (IE Once Planning application has been granted the Town and Parish Councils will be consulted on the aesthetics of the building and surrounds. This is seen by many public and councils as the removal of democratic rights.

Bristol is unable to meet the requirement for housing and this demand will be pushed onto SGC and BANES. In the JSP SGC took a further 7,000 houses from Bristol on top of their original quota.

(AC) proposed that the Planning Committee agree with the sentiments of CPRE as it is particularly relevant to Alveston which is washed over by Green Belt. This was agreed by all Councilors. (Clerk) asked the committee that if the Committee is to follow the sentiments of CPRE should the Parish Council write to Luke Hall too? All Clirs agreed.
